THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 20th October, 1955, published in Supplement No. 3 to the *Gazette* of the 24th October, 1955, under Notification No. 649 (hereinafter referred to as "the Order"), the Governor had authorized the use for airforce purposes of the land and property set out in the Second Schedule to the Order, situated at Trypiotis Quarter, Nicosia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months:
