P.I. 111/1960.***ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. The use of the said land by Her Majesty's Forces for military and security purposes is hereby authorised.

3. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

That part of plot 448 of the Government Survey Plan, Sheet XXXIII. 12.6.IV, Block D, Ayios Nikolaos Quarter, Varosha, delineated and shown in red on the plan dated 7th April, 1956, and signed by the Commissioner of Famagusta.

REGULATIONS, 1955 TO (No. 5) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 5) 1956.

ORDER MADE UNDER REGULATION 38 (1).

I, the Commissioner of Famagusta, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1956, do hereby order as follows :—

1. This Order may be cited as the Protected Areas (Famagusta District No. 2) Order, 1956.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955.

SCHEDULE.

The following lands at Varosha shown on sheets XXXIII.13.1.III, XXXIII.13.1.IV, XXXIII.13.4.I, and XXXIII.13.4.II of the Government Survey Plan :—

- (1) The sea shore and foreshore bounded on the north by a line extending the northern boundary of plot 167, Block C, in an easterly direction as far as the low water mark and on the south by a line extending the southern boundary of plot 272 in an easterly direction as far as the low water mark.
- (2) Plot 167 of Block C.
- (3) All that part of Franklin Roosevelt Avenue appearing on sheet XXXIII.13.1.IV.
- (4) All Hippocrates Street southwards from its junction with Franklin Roosevelt Avenue as far as the northern boundary of plot 274 of Block E.
- (5) All plots south of Franklin Roosevelt Avenue and east of Hippocrates Street from plot 164 to plot 272 inclusive.
- (6) Plots 273, 270, 269, 268, 731, 730, 245, 243, 242, 239, 238, 235, 234, 170, 586, 585 and 584 of Block E including the small area of road lying between plots 268 and 731.
