THE QUARANTINE LAW.
CAP. 145.

NOTIFICATION UNDER SECTION 4.

In exercise of the powers vested in him by section 4 of the Quarantine Law, Cap. 145, or otherwise, His Excellency the Governor is pleased to declare and hereby declares that Local Areas in the first Column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall as from the date hereof, be subjected to the measures prescribed by the Quarantine (Maritime and Aerial) Regulations, 1953 and 1954, with respect to the dangerous infectious diseases in the second column of the said schedule.

The Notification No. 345 published in Supplement No. 3 to the *Gazette* of 30th August, 1950, is hereby cancelled.

THE MISSIONARY EDUCATION AND MEDICAL (ALIEN
REGULATION) LAW.
CAP. 124.

PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Law, the person whose name appears in the Schedule hereto has applied for a permit under the provisions of the said Law ;

And whereas the said person has given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that she desires and purposes *ex animo* to work in friendly co-operation with the said Government in all matters in which her influence might properly be exerted ; and, in particular, she has undertaken that, if engaged in educational work, her influence will be exerted to promote loyalty to the Government of Cyprus in the minds of her pupils and to make them good citizens of the British Empire ;

Now, therefore, in exercise of the powers vested in him by section 8 of the Missionary Educational and Medical (Alien Regulation) Law, His Excellency the Governor, with the advice of the Executive Council, has

been pleased to grant to the person whose name appears in the Schedule hereto a permit respectively to commence or carry on the work set down after her name.

REGULATIONS, 1955 TO (No. 2) 1955.

ORDER MADE UNDER REGULATION 34 (1) (b).

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 2) 1955, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby prohibit the use of motor cycles and bicycles within the Municipal limits of Limassol between the hours of and 12 midnight as from today, the 9th January, 1956, and until further notice.
