THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1952.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1952, I, the Governor, do hereby make the following Regulations:—

1. These Regulations may be cited as the Emergency Powers (Public Safety and Order) (Amendment No. 7) Regulations, 1956, and shall be read as one with the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1956 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956.

Insertion of new Regulation 4A in the principal Regulations. 2. The principal Regulations are hereby amended by the insertion therein, immediately after Regulation 4, of the following new Regulation:—

"Power to take photographs, etc.

- 4A.—(1) Any police officer of or above the rank of Inspector may cause photographs, descriptions, measurements and finger prints to be taken of any person who is under arrest under the provisions of Regulation 3 of these Regulations, and any photograph, description, measurement and finger print so taken may be retained after the release of such person.
- (2) Any such person who shall refuse to submit in a proper manner to the methods of identification aforesaid shall be guilty of an offence against these Regulations.".

Insertion of new Regulation 34A in the principal Regulations.

3. The principal Regulations are hereby amended by the insertion therein, immediately after Regulation 34, of the following new Regulation:—
"Inform- 34A. Where it is alleged that a motor vehicle has been used

34A. Where it is alleged that a motor vehicle has been used in a manner prejudicial to public safety or to public order or in such other circumstances as shall make it desirable that the identity of the driver thereof shall be established—

- (a) the owner of the motor vehicle shall give such information as he may be required by or on behalf of the Commissioner of Police to give as to the identity of the driver and of any person using the motor vehicle, and, if he fails to do so, shall be guilty of an offence against this Regulation, unless he shows to the satisfaction of the Court that he did not know and could not with reasonable diligence have ascertained who was driving or using the motor vehicle; and
- (b) any other person shall, if required as aforesaid, give any information which it is in his power to give and which may lead to the identification of the driver or of any person using the motor vehicle, and, if he fails to do so, shall be guilty of an offence against this Regulation.",

4. Regulation 61 of the principal Regulations is hereby amended by the Amendment insertion therein, immediately after paragraph (3) thereof, of the following

new paragraph :-

"(4) In any prosecution under paragraph (1) of this Regulation, the onus of proving that there was in existence, at the material time, a trade dispute with which the strike or lock-out, which is the subjectmatter of the charge, could be connected, shall lie upon the accused:

Provided that a certificate under the hand of the Commissioner of Labour certifying that there was in existence a trade dispute, during any particular period, in relation to any particular trade, business or profession, may be produced by the accused and shall be prima facie evidence of the facts stated therein.".

5. Regulation 62A of the principal Regulations is hereby revoked and the Revocation following Regulation substituted therefor:

" Prohibition of swimming.

62A.—(1) The Commissioner of the District may, by Order, prohibit, within such area as may be specified in the Order.

- 1. This Order may be cited as the Emergency Powers (Control of Trawlers) Order, 1956.
