## THE CURFEWS LAWS, 1955.

LAWS 17 AND 47 OF 1955.

## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Limassol District No. 11) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 19th April, 1956.

## FIRST SCHEDULE.

The area of the town of Limassol within the following boundaries :—

From the sea immediately south of the junction of Byron Street and Sir Herbert Richmond Palmer Street ; along Byron Street, along the Limassol Bye-Pass to the junction with Victoria Street, along Victoria Street to the Vathias River bridge, along the eastern bank of the Vathias River to Eleftheria Street, along Eleftheria Street to the junction with Victoria Street ; along Victoria Street to the Limassol Customs entrance.

## SECOND SCHEDULE.

From 10.00 a.m. on the 19th April, 1956, until 05.00 a.m. on the 20th April, 1956.

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 22nd day of April, 1956.

#### FIRST SCHEDULE.

##### No. 1 Area.

Bounded on the south by Athena Street and Konia Road.

Bounded on the west by Road running north from junction of Thermopiles Street and Fellah Oglou Street.

Bounded on the north by a line running from the junction of Konia Road and Vasilikou Road to Pinefield Camp.

All Roads mentioned are inclusive to the curfew.

##### No. 2 Area.

Bounded on the south by the sea shore.

Bounded on the west by the Kato Paphos Road.

Bounded on the north by Gladstone Street.

Bounded on the east by Athenon Street, Prince of Wales Street and a line extending from there to the seashore.

All roads mentioned are inclusive to the curfew except Athenon Street.

#### SECOND SCHEDULE.

Curfew from 19.00 hrs. to 04.00 hrs. daily until further notice, commencing at 19.00 hrs. Sunday the 22nd April, 1956.

#### THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 6) 1956.

##### ORDER MADE UNDER REGULATION 40.

In exercise of the powers vested in me by Regulation 40 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1956, I, William Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby order that all establishments owned by Cypriot Greeks, and situated within the Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa shall be closed, and shall remain closed between the hours of 7 a.m. on the 25th April, 1956, and 7 a.m. on the 2nd May, 1956, inclusive :

Provided that hotels may remain open for the purposes of catering for residents staying therein.
