THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 7) 1956.

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in the Governor under Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956, and delegated to me by Notification No. 807, published in Supplement No. 3 to the *Gazette* of 27th December, 1955, I, Warren Frederick Martin Clemens, the Commissioner of Nicosia, do hereby prohibit :—

1. The use of all motor vehicles including pedal cycles and motor cycles within the Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa as from 17.00 hours on Tuesday, 8th May, 1956, until further notice.

2. The parking or leaving of pedal cycles or motor cycles in or on the public roads within the areas defined above during the continuance of this Order.

3. The parking of motor vehicles in or on the public roads within the walled area of Nicosia during the continuance of this Order :

Provided that paragraph 1 and 3 of this Order shall not apply to vehicles driven by :—

- (a) the holders of official curfew passes issued by the Commissioner of Nicosia or by the Assistant Commissioner of Police of the Nicosia Division for driving the vehicle or vehicles indicated on their said pass ;
- (b) persons of non-Cypriot origin subject to the production on demand of a passport or identity card ;
- (c) public omnibuses, lorries and vans engaged on legitimate commerce or trade ;
- (d) Her Majesty's Forces, the Cyprus Government Service and the Cyprus Police Force in uniform.

This Order shall, during its operation, supersede all other Orders previously made by me under Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 6) 1956.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice as follows :—

The fourth line of the Schedule to the Order made on the 22nd March, 1956, and published in Supplement No. 3 to the *Gazette* of 2nd April, 1956, under Notification No. 263 is hereby amended by the addition after the word " red " of a comma, followed by the insertion, before the word " on ", of the words " and part of plots 963 and 980 more particularly defined as the area coloured green ".
