ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

All fences, of whatever material, in Stavros Quarter, Varosha (Sheets XXXIII.21.I.I., XXXIII.21.I.II and XXXIII.21.I.IV of the Government Survey Plan) erected on the boundaries—

(a) between Hesperides Street and plots 11, 12 and 14 of Block C;

(b) between plots 11 and 288 of Block C;

(c) between Hesperides Street and plots 725 of Block A and 56 of Block A east of Stavros Church,

together with all Canes, Grass, Cactus and other vegetation standing on the same boundaries and within ten feet of Hesperides Street or of plot 288 of Block C.

2. Her Majesty's Forces are hereby authorized to do in relation to the land-anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.
