

No. 388. THE SOIL CONSERVATION LAW, 1952.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Law, 1952, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed at Ayios Theodhoros (Larnaca) village in respect of the area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 71 of the Government Survey Plan No. XLIX.64, locality "Aloupaki", and proceeds in an easterly direction along the boundaries of and including the said plot, plots Nos. 70, 96, 100, 101, 66, 67, 102, 103, 99, 158, 105, 60, 108, 56, 57, 19, 18, 54, 50, 50/1, 48, 46, 44, 115, 134, 134/1, 133/1, 132, 129, 127 and 125 of the said plan, plot No. 5 of the Government Survey Plan No. L.57, to the most northern point of the said plot, which point is on the boundary between the villages of Ayios Theodhoros and Alaminos ; thence in a south-easterly direction along the said village boundary (excluding plots Nos. 25, 27 and 55 of the Government Survey Plan No. L.57) to the south-eastern corner of plot No. 14 of the Government Survey Plan No. LVI.1, locality "Tourkos" ; thence in a westerly and northerly direction along the boundaries of and including the said plot, plots Nos. 13, 12, 11 and 10 of the said plan, Plot No. 74 of the Government Survey Plan No. L.57, plots Nos. 9, 9/1, 9/2, 29, 30, 32, 33, 34, 37, 38, 40, 41, 46, 99, 102 and 100 (part) of the Government Survey Plan No. LVI.1, plots Nos. 39, 24/1, 24, 24/2, 25, 50, 49, 54, 59, 63, 62, 61, 51, 22 and 23 of the Government Survey Plan No. LV.8, plots Nos. 307, 306, 304, 300, 256, 255, 250, 248, 247, 207, 203, 198, 197, 194, 161, 162, 97, 96 and 71 of the Government Survey Plan No. XLIX.64 to the point of commencement, all which said boundary is more particularly delineated in red on the plan marked Ayios Theodhoros (Larnaca) Soil Conservation Division signed by the Director of Agriculture and dated the 25th April, 1956, a copy of which has been deposited in his office at Nicosia.

But excluding the area under plots Nos. 136, 138, 219, 220, 236, 310, 311 (part), 221, 222, 223, 224, 225, 226, 227 and 230 of the Government Survey Plan No. XLIX.64, plots Nos. 12, 39, 38/1, 38/2, 38/3, 38/4, 38/5/1, 38/5/2, 36, 37, 62, 67, 68, 69, 61 and 60 of the Government Survey Plan No. L.57, plots Nos. 5, 31/1, 31/2/1 and 31/2/2 of the Government Survey Plan No. LVI.1, all which said area is more particularly defined as the area hatched black on the said plan marked Ayios Theodhoros (Larnaca) Soil Conservation Division.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

Some 150 spillways will be constructed on about 540 donums of the total area of 2,600 donums and a good deal of levelling carried out ; about 1,600 donums will be improved by the construction of earth bunds graded towards a waterway which will be cascaded ; and the remaining 460 donums will be developed by the construction of gradoni terraces.
