ORDER MADE UNDER REGULATION 62A.

In exercise of the powers vested in me by Regulation 62A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956, I, the Commissioner of Famagusta, do hereby order as follows:—

- 1. This Order may be cited as the Prohibition of Swimming (Famagusta District No. 1) Order, 1956.
- 2. No person shall swim within the area specified in the First Schedule hereto except under the written authority of the Port Superintendent, Famagusta.
- 3. No person shall swim underwater with the aid of any artificial breathing apparatus within the area specified in the Second Schedule hereto except under the written authority of the Port Superintendent, Famagusta.
- 4. The Order made on the 11th April, 1956, and published in Supplement No. 3 to the *Gazette* of 19th April, 1956, under Notification No. 318 is hereby cancelled.

FIRST SCHEDULE.
