REGULATIONS MADE UNDER SECTION 33.

In exercise of the powers vested in him by section 33 of the Secondary Education Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make and hereby makes the following Regulations :-

1. These Regulations may be cited as the Secondary Education (Amend-Education Regulations (hereinafter referred to as "the principal p. 504. Regulations").

THE WATER (DEVELOPMENT AND DISTRIBUTION) LAWS, 1955 AND 1956.

DECLARATION OF AREA UNDER SECTION 3.

Whereas it appears to the Governor-in-Council that the conservation and better use of water resources within the area described in the Schedule hereto (hereinafter referred to as "the area"), the provision of sufficient water supplies therein and their equitable distribution and availability at fair prices may be more effectively secured by the declaration of the area as a development area :

Now, therefore, in exercise of the powers vested in him by section 3 of the Water (Development and Distribution) Laws, 1955 and 1956, His Excellency the Governor has been pleased, with the advice of the Executive Council, by this Order to declare the area to be a development area for the purposes of the aforesaid Laws.

SCHEDULE.

The area comprising all the lands registered or recorded in the books of the Land Registry Office, within the villages of Kythrea, Khrysidha, Neokhorio, Trakhoni, Voni, Epikho, Bey Keuy, Palekythro and Exometokhi.
