

**No. 442.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 7) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

**SCHEDULE.**

All canes, cactus and other vegetation standing between the Famagusta-Dherinia road and the fruit trees in the following plots shown on Sheet XXXIII.20.3.IV of the Government survey plan :

- (1) Plot 516, Block F, Ayia Zoni Quarter, southward from the area covered by the order published under Notification No. 370 in Supplement No. 3 to the *Gazette* dated 3rd May, 1956.
- (2) Plots 539, 540, 533, 534, 535 and 536, Block F, Ayia Zoni Quarter.
- (3) Plot 159, Block J, Ayia Zoni Quarter.
