**THE WATER (DEVELOPMENT AND DISTRIBUTION) LAWS,**  
**1955 AND 1956.**

**ORDER UNDER SECTION 4.**

Whereas by a declaration of the Governor-in-Council under section 3 of the Water (Development and Distribution) Laws, 1955 and 1956, dated the 29th May, 1956, and published in Supplement No. 3 to the *Gazette* of the 30th May, 1956, the area comprising all the lands registered or recorded in the books of the Land Registry Office within the villages of Kythrea, Khrysidha, Neokhorio, Trakhoni, Voni, Epikho, Bey-Keuy, Palekythro, and Exometokhi, has been declared as a development area for the purposes of the Water (Development and Distribution) Laws, 1955 and 1956 (hereinafter referred to as "the Laws").

Now, therefore, in exercise of the powers vested in him by section 4 of the Laws His Excellency the Governor has been pleased to establish a Water Development Committee in respect of the said area and to appoint the Commissioner of Nicosia and Kyrenia as Chairman of the said Committee and the Director of Water Development and the Commissioner of Famagusta as members thereof, who shall hold office for a period of four years after the date hereof in accordance with the provisions of the said section 4.

**THE LAND ACQUISITION LAW.**  
**CAP. 233 AND LAWS 26 OF 1952 AND 43 OF 1955.**

**NOTIFICATION UNDER SECTION 7.**

Whereas by Notification No. 497 published in Supplement No. 3 to the *Gazette* of the 12th August, 1954 (as amended by Notification No. 561 published in Supplement No. 3 to the *Gazette* of the 9th September, 1954), the Governor declared the provision of new main roads in the town of Nicosia and in the villages of Ayios Dhometios, Strovolos, Orta Keuy and Engomi, and the protection thereof, to be an undertaking of public utility ;

And whereas the Commissioner of Nicosia and Kyrenia in compliance with section 6 of the Land Acquisition Law, by a notice published under Notification No. 640 in Supplement No. 3 to the *Gazette* of the 4th November, 1954, gave particulars of the lands required in connection with the aforesaid undertaking (hereinafter referred to as the "lands") ;

And whereas the Commissioner of Nicosia and Kyrenia forwarded to the Governor a plan of the lands together with the required particulars as regards their owners and descriptions and the objections made ;

And whereas, having considered the objections made thereto, the Governor's Deputy has approved the plans submitted, and has considered it expedient, having regard to all the circumstances of the case, that only that part of the lands described in the Schedule hereto should be acquired :

Now, therefore, in exercise of the powers vested in the Governor by virtue of section 7 of the Land Acquisition Law, the Governor's Deputy hereby sanctions the acquisition of that part of the lands described in the Schedule hereto.

**SCHEDULE.**

All those areas of privately-owned lands, with everything standing thereon, situated in the villages of Engomi and Strovolos and in Ayii Omoloyitadhes and Trypioti Quarters of Nicosia Town, comprising 46

donums and one evlek or thereabouts including parts of plots Nos. 253 (part of former plot No. 1), 3, 5, 26, 27, 20, 255, 28 and 29 and the whole of plot No. 4 of Block D, Engomi, part of plots Nos. 96, 95 and 223 (part of former plot No. 83) of Block B of the said village, part of plots Nos. 88 and 87 of Block D, Strovolos, part of plot No. 315, the whole of plots Nos. 322, 321, 316, 317, 320, 319 and 318, part of plots Nos. 311, 306, 377, 74 and 2, the whole of plot No. 73, part of plots Nos. 71, 474, 4, 5, 441, 600 (part of former plot No. 8), 469, 470 and 472, the whole of plot No. 419 and part of plots Nos. 17, 16, 15 and 10 of Block A, Ayii Omoloyitadhes Quarter, Nicosia, part of plots Nos. 433, 432, 62/1, 62/2, 434 and 574 of Block 25, Trypioti Quarter, Nicosia, part of plots Nos. 1, 418, 422, 423, 16, 308, 307, 273, 4, 5, 274, 226, 252, 253, 254, 258, 257, 255, 11, 224, 256 and 12 of Block B, Ayii Omoloyitadhes Quarter, Nicosia, part of plots Nos. 69/5, 148 and 70 of Block 25, Trypioti Quarter, Nicosia and part of plots Nos. 15, 12 and 14 of Block C, Ayii Omoloyitadhes Quarter, Nicosia, more particularly defined as the areas coloured red and green on the plans marked "Trunk Road A, Nicosia" dated the 23rd May, 1956, and deposited in the Nicosia office of the Commissioner of Nicosia and Kyrenia.

The areas coloured green on the said plans shall form "road protecting strips" and shall not be ceded to the public road.

# THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952 AND 43 OF 1955.

## NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 68 in Supplement No. 3 to the *Gazette* of the 13th February, 1952, as amended by Notification No. 362 in Supplement No. 3 to the *Gazette* of the 3rd May, 1956, notice is hereby given that the following lands and easements are required by the Governor for the undertaking of public utility mentioned therein—

- (a) All those areas of privately-owned lands situated at Kato Lakatamia, comprising 5½ donums or thereabouts being parts of plots Nos. 281 and 283 of Block C, Kato Lakatamia, more particularly defined as the areas coloured blue on the plan marked "NICOSIA AIR-FIELD—RUNWAY LOCATOR BEACON", signed by the Director of Civil Aviation and dated the 3rd March, 1956.
- (b) A right of way over, and a right to lay, repair and maintain electrical power and control cables under, the privately-owned lands under plots Nos. 281 and 283 of Block C, Kato Lakatamia. The position of the right of way and the electricity way leave is more particularly defined by the areas coloured yellow and red, respectively, on the said plan.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. The plan referred to above is available for inspection at my Office.
