REGULATIONS, 1955 TO (No. 7) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 7) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

1. All canes, cactus and other vegetation standing between the fruit trees in plots 145 and 146, Block F, Ayia Zoni Quarter, Varosha, and the road linking Demophon Street and Ploutarchus Street behind Manzourion School.

2. All vegetation and all fences whether of brushwood or other material in plots 691, 457 and 771, Block F, Ayia Zoni Quarter, Varosha, within twelve feet of Ploutarchus Street.

3. All vegetation in plot 413, Block F, Ayia Zoni Quarter, Varosha, within nine feet of Ploutarchus Street or of Dionysos Street.

All vegetation standing in plot 407, Block A, Kato Varosha Quarter, Varosha, within twelve feet of Demophon Street or Khrysospiliotissa Street together with the low wall preventing access from Demophon Street to the said plot for a distance of 150 feet or thereabouts northwards from the boundary of plot 53.

2. All land in plots 22, 23, 24 and 44, Block A, Kato Varosha Quarter, within twelve feet of Kato Varosha road.

3. All canes and other vegetation in plots 45, 170 and 168, Block A, Kato Varosha Quarter, within twelve feet of Kato Varosha Street.

SCHEDULE.

1. All land at Plots 108 and 194, Block C, Ayios Memnon Quarter, within 12 feet of the road bounding the Plots on the northern side.

2. The wall and fence preventing access to Plots 109 and 110, Block C, Ayios Memnon Quarter, from Hesperidon Street.

3. All vegetation standing between the fruit trees in Plot 384, Block F, Ayia Zoni Quarter, Varosha, and

(a) Dherinia Road,

(b) The road bounding the plot along the southern side.

4. The corrugated iron fence preventing access to the Regina Garden Cabaret from Franklin Roosevelt Avenue.
