**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.**

ORDER MADE UNDER REGULATION 39.

Whereas I, Warren Frederick Martin Clemens, Commissioner of Nicosia, after due enquiry am satisfied that the premises set out in the Schedule hereto have been used or are intended to be used in a manner prejudicial to the interest of public order and safety :

Now, therefore, in exercise of the powers vested in me by Regulation 39 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and with the approval of His Excellency the Governor, I hereby order that the premises set out in the Schedule hereto shall be closed and remain closed for a period of three months as from 24th May, 1956, until 23rd August, 1956, inclusive.

SCHEDULE.

1. Phaneromeni Church and its precincts situate at Phaneromeni, Street, Nicosia, PROVIDED THAT the Church building itself excluding the yard thereof will remain open for general religious purposes under arrangements to be made by the priest in charge of the church with the Commissioner of Nicosia.
2. The Pancyprian Academy for Girls situate at Ledra Street, Pygmalion Street, Nicosia.
3. The Office block of buildings known as Kykko Buildings situate at Ledra Street and Kykko Avenue.
4. The dwelling house at No. 41, Phaneromeni Street, Nicosia.

ORDER MADE UNDER REGULATION 3.

Whereas offences have been committed within the areas set out in the Schedule hereto :

And whereas I, Warren Frederick Martin Clemens, Commissioner of Nicosia, after due enquiry am satisfied that the inhabitants of the said

areas have failed to render all the assistance in their power to discover the offenders :

Now, therefore, in exercise of the powers vested in me by Regulation 3 of the Emergency Powers (Collective Punishment) Regulations, 1955, and with the approval of His Excellency the Governor, I do hereby order that the dwelling houses, the particulars of which are given in the Schedule hereto, situate within the said areas, shall be closed and kept closed and unavailable for human habitation for a period of three months as from 24th May, 1956, until 23rd August, 1956.
