THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

1. All vegetation in plot 324, Block C, Stavros Quarter, within twelve feet of—

(a) Hesperidon Street,

(b) The road bounding the plot along its north-western side.

2. All canes and other vegetation in plot 212 Block A, Stavros Quarter, within 12 feet of Hesperidon Street, together with the fence preventing access to the plot from the Street.

3. The fences and walls, other than walls forming part of any dwelling house, preventing access to plot 38, Block C, Ayios Memnon Quarter, from Hesperidon Street.
4. The fence preventing access to plot 113, Block C, Ayios Memnon Quarter, from Hesperidon Street.

SCHEDULE.

1. All trees and other vegetation within 15 feet of Hesperidon Street in plot 91, Block C, Stavros Quarter, south of the dwelling house in the plot shown, on Sheet XXXIII.21.5.1 of the Government Survey Plan, as abutting on the street.
2. All trees and other vegetation in plots 57 and 58, Block C, Stavros Quarter, within 15 feet of Hesperidon Street together with all fences blocking access from the street to the two plots.
3. The walls (other than those forming part of any dwelling house) preventing access from Hesperidon Street to plot 52, Block C, Stavros Quarter.
4. All canes and other vegetation in plot 274, 281 and 282, Block C, Stavros Quarter within twelve feet of Hesperidon Street, together with all fences preventing access to the plots from the street.
