ORDER MADE UNDER REGULATION 34 (1) (b). *Reginald*

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 807, I, the Commissioner of Larnaca, hereby prohibit the use of all motor vehicles within the Municipal limits of Larnaca, between the hours of 7.00 p.m. and 4 a.m. daily from Monday, May 28th, 1956, until further notice.

ORDER MADE UNDER REGULATION 34 (1) (b). *Reginald*

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I the Assistant Commissioner of Kyrenia, hereby prohibit the use or circulation of motor cycles and bicycles within the municipal limits of Kyrenia between the hours of 7.15 p.m. and 4.30 a.m. as from today the 5th June, 1956, and until further notice.

2. I further order that no motor cycle shall be left on any public street or place or any bicycle out of doors during the prohibited hours.

3. Notification No. 269 published in Supplement No. 3 to the *Gazette* of the 5th April, 1956, is hereby cancelled.

ORDER MADE UNDER REGULATION 39 (1). *Reginald*

I, Assistant Commissioner of Kyrenia, in exercise of the powers vested in me by paragraph 1 of Regulation 39 of the Emergency Powers (Public Safety and Order) Regulations, 1955, do hereby order as follows:—

1. This Order may be cited as the Closing of Premises (Kyrenia District No. 1) Order, 1956.

2. That in the interests of public order, safety or defence the premises described in the Schedule hereto shall be closed with effect from the 24th May, 1956, and remain closed until further Order.
