PROCLAMATION UNDER SECTION 18.

Whereas it is expedient to amend the boundaries of the Ayios Memnon and Kato Varosha quarters of the Town of Famagusta and Varosha in the District of Famagusta :

Now, therefore, in exercise of the powers vested in me by section 18 of the Village Authorities Law, and of every other power and authority enabling me in that behalf, I, the Governor's Deputy, do hereby proclaim that from and after the 1st day of July, 1956, the area described in the Schedule hereto, heretofore reckoned within the boundaries of the Ayios Memnon quarter, shall form part of the lands of Kato Varosha quarter of the Town of Famagusta and Varosha in the District of Famagusta and the boundaries of the said Ayios Memnon and Kato Varosha quarters as proclaimed on the 27th day of November, 1948, and published under Notification No. 426 in Supplement No. 3 to the *Gazette* of the 2nd December, 1948, shall be altered accordingly.

I, the Governor's Deputy, in exercise of the powers conferred on me by section 6 of the Municipal Corporations Law, and of every other power and authority enabling me in that behalf, do hereby declare that from and after the 1st day of July, 1956, the limits of the Municipal Corporation of Famagusta shall be extended to include the area described in the Schedule hereto and that the limits of the said Municipal Corporation as published under Notification No. 310 in Supplement No. 3 to the *Gazette* of the 7th August, 1940, shall be altered accordingly.

SCHEDULE.

*Area to be transferred from Engomi village to Famagusta and Varosha Town.*  
The boundary commences at a corner of the bridge carrying the Famagusta-Karpas road over the river Yialias at the locality "Pallourka" which

corner is on the right bank of the said river, and proceeds north-eastwards along the said bank of the said river to the sea-shore ; thence south-eastwards along the sea-shore to the north-eastern corner of plot No. 166.8 of the Government Survey Plan No. XXIV.51.E ; thence in a straight line, in extension of the northern boundary line of the said plot, to the boundary of the Town of Famagusta and Varosha ; thence south-westwards and westwards along the said boundary to the north-western corner of plot No. 12 of the Government Survey Plan No. XXIV.59.W, which corner is on the right bank of a water channel ; thence north-westwards along the said bank of the water channel to its junction (across a ford) with the river Yialias, which junction is on the right bank of the said river ; thence northwards along the said bank of the said river to the point of commencement ; all which said boundary is shown delineated in red on the Government Survey Plan Serial No. 1636.

**THE EMERGENCY POWERS (REGISTRATION AREAS)  
REGULATIONS, 1956.**

ORDER MADE UNDER REGULATIONS 3 AND 4.

In exercise of the powers vested in the Governor by Regulations 3 and 4 of the Emergency Powers (Registration Areas) Regulations, 1956, I, the Governor's Deputy, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Registration Areas) (Troodos Sub-Area) (No. 2) (Amendment) Order, 1956, and shall be read as one with the Emergency Powers (Registration Areas) (Troodos Sub-Area) (No. 2) Order, 1956 (hereinafter referred to as "the principal Order").

2. The principal Order is hereby amended by the deletion from the Schedule thereof of the following villages :

Agrolahdou, Lemonas and Alassa (Khalassa).

**No. 590. THE PUBLIC HEALTH (VILLAGES) LAW.  
CAP. 142.**

ORDER IN COUNCIL No. 2841

MADE UNDER SECTION 10.

*Authority to the Village Health Commission of Korovia  
(Famagusta District) to contract a loan.*

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, the Governor's Deputy, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Village Health Commission of Korovia (Famagusta District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of three hundred pounds (£300) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say :—

(a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in six equal annual instalments (comprising sinking fund and interest);
