THE EMERGENCY POWERS (EXTENDED JURISDICTION
OF JUSTICES OF THE SPECIAL COURT) REGULATIONS, 1956.

ORDER MADE UNDER REGULATION 3.

In exercise of the powers vested in him by Regulation 3 of the Emergency Powers (Extended Jurisdiction of Justices of the Special Court) Regulations, 1956, His Excellency the Governor, on the recommendation of the Chief Justice, has been pleased to order that Mr. Reginald Cuthbert Stockdale Ellison, a Justice of the Special Court, be invested with power to try such specified offences as the Chief Justice may, from time to time, direct and which, but for the provisions of the said Regulations, would only be triable by a Judge of the Special Court.

No. 595. THE SUPPLIES AND SERVICES (TRANSITIONAL
POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR'S DEPUTY UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1955), the Governor's Deputy by this Order, orders as follows:—

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land and property specified in the Second Schedule (hereinafter referred to as "the land") during the period of six months from the date of this Order is hereby authorized.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.

3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE.

1. The land shall be occupied and used for military purposes only.

2. At the expiration of this Order the land shall be restored to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of this Order.

3. Compensation shall be paid to the persons having an interest on the land for its use and occupation under this Order.

SECOND SCHEDULE.

All those areas of privately-owned land, situated in Yermasoyia village, as follows:—

(a) part of plot No. 131 of the Government Survey Plan No. LIV.52, excluding the buildings standing thereon and the access to the said buildings from the Limassol-Nicosia main road;

(b) a strip ten feet wide, forming part of plots Nos. 132/1/2 and 132/3 of the said plan.

All which said areas are more particularly defined as the areas coloured red on the plan signed for the Assistant Director of Hirings, Cyprus, dated the 7th June, 1956, and deposited in the office of the Commissioner, Limassol.
