## THE CURFEWS LAWS, 1955.

LAWS 17 AND 47 OF 1955.

## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Larnaca District No. 12) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Larnaca, or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 21st day of June, 1956.

## FIRST SCHEDULE.

Within the Municipal area of Larnaca ; that part of Larnaca from the junction of Evryviadhes Street and Marina Street ; along Marina Street to its junction with Small Jetty Street ; along Small Jetty Street to its junction with Kleanthis Kaloghera Street ; along Kleanthis Kaloghera Street to its junction with Zinonos Kitieos Street ; along Zinonos Kitieos Street to its junction with Evryviadhes Street and along Evryviadhes Street to the point of commencement, inclusive.

From 09.00 hrs. to 18.00 hrs. on 21st June, 1956.

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 18th day of June, 1956.

DIRECTIONS GIVEN UNDER SECTION 15.

In exercise of the powers vested in me by section 15 of the Port Regulation Law, I, the Superintendent of Famagusta Port, do hereby give the following directions :—

- (i) Save with my permission in writing, navigation by any vessel is prohibited within the area described in the First Schedule hereto and marked by red cylindrical buoys.
- (ii) Within the limits of Famagusta Port as defined in Part I of the Schedule to Order in Council No. 2725 published in Supplement No. 3 to *Gazette* No. 3799 of the 26th December, 1954, no power-driven vessel shall proceed at a speed in excess of five nautical miles per hour in the area specified in the Second Schedule hereto.

FIRST SCHEDULE.

The coast of Cyprus, a line drawn  $171^{\circ}$  from the high water mark on the beach at the easternmost point of the Ghlossa and a line drawn  $061^{\circ}$  from the south-eastern corner of plot 565 of Block E, Ayios Nikolaos Quarter, Varosha, Sheets XXXIII.13.IV and XXXIII.13.4.II of the Government Survey Plan.
