**No. 646.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 8) 1956.****ORDER MADE UNDER REGULATION 34 (1).**

In exercise of the powers vested in the Governor under regulation 34 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and duly delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Nicosia, hereby prohibit until further notice the use by Civilian traffic on that part of the Milikouri-Chakistra road commencing at the point of its junction with the road coming from Pedhoulas and proceeding in a north-westerly direction through the Kykko Monastery for a distance of one mile from the said Monastery, except between 06.00 and 07.00 hours in the mornings and 18.00 and 19.00 hours in the afternoons daily.

2. For the purpose of this Order "Civilian traffic" means all vehicular or mounted traffic by persons other than members of H.M. Forces or the Police Force and includes pedestrians.

3. This Order shall come into force as from the 24th day of June, 1956.
