

No. 680.**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.****ORDER MADE UNDER REGULATION 34 (1) (b).**

In exercise of the powers vested in the Governor under Regulation 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia, hereby prohibit the use of all types of vehicles on all the roads within the boundaries of Karvounas cross road north to Evrykhrou, thence along the lateral road through Nikitari, Vyzakia, Ayia Marina, Kato Moni, Mitsero, Eliophotes, Agrokippia, Malounda and thence along the main road south to the Papoutsas cross road and thence along the Nicosia-Limassol District boundary to Karvounas cross roads including the village areas of all the villages situated on these boundaries, from 04.00 hours on 5th July, 1956, until further notice :

Provided that this order shall not apply to the movement of any type of vehicle between 04.00 hours and 06.00 hours and 17.00 hours and 19.00 hours daily as from 04.00 hours on 6th July, 1956.

REGULATIONS, 1955 TO (No. 8) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety I have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said properties for occupation as residential quarters by expatriate British families permanently or temporarily resident in the island is hereby authorized.

3. The authority using the properties in pursuance of this order is entitled to do thereon or in relation thereto such acts as may be necessary for the purpose of their occupation.

4. The exercise of any right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

SCHEDULE.

(a) The ground-floor flat (No. 7) and all appurtenances thereto situated at 2, Laskaris Street, Ayios Andreas Quarter, Nicosia, Plot No. 192, Block C, Ay. Andreas Quarter, Nicosia, Sheet No. XXI/45.6.II and IV of the Government Survey Plan.

(b) The ground-floor house and all appurtenances thereto situated at No. 3, Harold Nicholson Street, Ayii Omoloyitadhes Quarter, Nicosia, Plot No. 439, Block B, Ayii Omoloyitadhes Quarter, Nicosia, Sheet No. XXI/54.4.II and IV of the Government Survey Plan.

The said properties are more particularly defined as the areas coloured red on the plans signed by the Commissioner of Nicosia, dated the 3rd day of July, 1956, and deposited in his office in Nicosia.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the community, have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said land as a Police Station is hereby authorized.
3. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.
4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

The land together with the houses, trees, vineyards and all that appertains thereto or stands thereon, situated at Alona village and forming plots Nos. 1175/1, 1175/3, 1175/4, 1175/5, 1176, 1177 and 1180 of the Government Survey Plan No. XXXVIII/50, more particularly defined as the area coloured red on the plan signed by the Commissioner of Nicosia and Kyrenia, dated the 7th July, 1956, and deposited in his office at Nicosia.
