THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1952.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1952, I, the Governor, do hereby make

1. These Regulations may be cited as the Emergency Powers (Public Short title. Safety and Order) (Amenciment No. 3) Regulations, 1956, and shall be read Gazettes : as one with the Émergency Powers (Public Safety and Order) Regulations, 1955 to (No. 2) 1956 (hereinafter referred to as "the principal Regulations "), and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Public Safety and Order) Regulations, 1955 to 14.12.1955 (No. 3) 1956.

2. Paragraph (1) of Regulation 2 of the principal Regulations is hereby Amendment amended by the insertion therein, in its proper alphabetical place, of the of Regulation following definition :-

principal "' member of Her Majesty's Naval, Military or Air Forces' includes Regulations. persons who are War Department Auxiliary Policemen and Royal Air Force Auxiliary Policemen, when acting in the course of their duties as such ; ".

3. The prigripal Regulations are hereby amended by the insertion therein, Insertion immediately after Regulation 24, of the following new Regulation :---

"Power to 24A.—(1) The Governor may direct any police officer or 24A in the seize other person to seize and take possession ofprinting

press and premises used for printing.

(a) any printing press which the Governor has reasonable Regulations. cause to believe has been used for the printing of any newspaper or document the printing or publishing of which contravenes any of the provisions of these Regulations or of any Law in force for the time being, or in respect of which any person has been convicted of an offence under any Law relating to sedition or seditious publications ;

(c) any premises in which such printing press, type, machinery, apparatus or equipment may be found or in which the Governor has reasonable cause to believe that any such newspaper or document as aforesaid has been printed or published.

(2) Any article or premises seized under this Regulation shall be disposed of as the Governor may order.".

4. Regulation 32 of the principal Regulations is hereby revoked.

Revocation of Regulation 32 of the principal Regulations.

Amendment of Regulation 33 of the principal Regulations

5. Paragraph (1) of Regulation 33 of the principal Regulations is hereby amended by the insertion therein, immediately before the word "give" (line 4), of the word "may".

6. Regulation 58 of the principal Regulations is hereby amended as follows:--

- (a) by the substitution for the brackets and words "(civil or military)", occurring in line 2 of sub-paragraph (a) thereof, of the brackets and words "(civil, naval, military or air force)";
- (b) by the substitution for the words "this sub-regulation", occurring in line 2 of sub-paragraph (c) thereof, of the words "this Regulation".
