

**No. 689. THE FORESHORE PROTECTION LAW.**

CAP. 92 AND LAW 16 OF 1954.

**NOTICE UNDER SECTION 3 (1).**

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I do hereby prohibit :

- (a) the removal of stones, gravel, shingle, sand or other substances, save under a written permit from me and under such conditions as I may impose, from all parts of the foreshore lying within the Municipal limits of Larnaca, provided that stones, gravel, shingle and sand may be removed under the directions of the Collector of Customs, Larnaca, for use as ballast for sailing vessels from that part of the foreshore lying between the main pier and the Quarantine Jetty ;
- (b) the dumping of rubble, rubbish, sweepings, litter, nightsoil or other refuse on any part of the foreshore within the Municipal limits of Larnaca.

2. The notice published under Notification No. 528 in Supplement No. 3 to the *Gazette* No. 3657 of the 26th November, 1952, is hereby cancelled without prejudice to anything done thereunder.

**No. 690. THE FORESHORE PROTECTION LAW.**

**NOTICE UNDER SECTION 3 (1).**

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I do hereby prohibit the removal of stones, gravel, shingle, sand or other substances, save under a written permit from me and under such conditions as I may impose thereby, from those areas of foreshore described in Schedules I and II hereto.

The notices published under Notifications No. 65 in Supplement No. 3 to the *Gazette* No. 3671 of the 11th February, 1953, and No. 299 in Supplement No. 3 to the *Gazette* No. 3560 of the 6th June, 1951, and Notification No. 1203 in the *Gazette* No. 2469 of the 11th October, 1935, are hereby cancelled without prejudice to anything done thereunder.

**SCHEDULE I.**

Commencing at M.R. S.163250 on map GSGS 4242, sheet 13, Edition 4, in a north-easterly direction to the point at which the southern boundary of Larnaca Municipality intersects the foreshore.

**SCHEDULE II.**

Commencing at the point where the northern boundary of Larnaca Municipality intersects the foreshore thence in a north-easterly direction to M.R. S.450464 on map GSTS 4242, Sheet 13, Edition 4.
