## BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.

In exercise of the powers vested in them by section 125A of the Municipal Cap. 252. reporations Law and of every other power thereunto enabling, the Council 11 of 1950 the Municipal Connection of Nicosia, with the concurrence of the 31 of 1951 Corporations Law and of every other power thereunto enabling, the Council of the Municipal Corporation of Nicosia, with the concurrence of the 20 of 1953 Commissioner of Police, hereby make the following bye-laws :--

1. These bye-laws may be cited as the Nicosia Municipal (Traffic) Gazettes : (Amendment) Bye-laws, 1956, and shall be read as one with the Nicosia Supplement Municipal (Traffic) Byc-laws, 1950, and that be read as one with the refersal Doparties No. 3: principal Bye-laws "), and the principal Bye-laws and these bye-laws may 19.11.1952 together be cited as the Nicosia Municipal (Traffic) Bye-laws, 1952 to 1956. 29.12.1955.

2. The proviso to bye-law 13 (o) of the principal Bye-laws is hereby deleted and the following proviso substituted therefor :-

"Provided that in the case of a motor vehicle such speed shall not exceed thirty miles per hour or such lesser speed as may be indicated by a street sign in respect of the street to which such sign relates, and any speed in excess of such speed shall be deemed to be a speed likely to endanger human life or to cause harm or injury to any person or property within the meaning of Bye-law 13 (0) ".

The above Bye-laws have been approved by His Excellency the Governor. (M.P. 1093/55/A.)
