THE AGRICULTURAL PRODUCE (EXPORT) (DECLARATION) ORDER, 1956.

NOTICE UNDER PARAGRAPH 2.

In exercise of the powers vested in me by paragraph 2 of the Agricultural Produce (Export) (Declaration) Order, 1956, I, the Director of Commerce and Industry, do hereby direct as follows :—

1. The provisions of the Agricultural Produce (Export) Law shall be suspended in relation to barley and wheat during the period ending 31st December, 1956.

2. This notice shall be deemed to have come into operation on 20th January, 1956.

No. 694. THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951, 20 OF 1953, 29 OF 1954,
57 OF 1954 AND 14 OF 1955.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF NICOSIA.

In exercise of the powers vested in them by section 125A of the Municipal Corporations Law and of every other power thereunto enabling, the Council of the Municipal Corporation of Nicosia, with the concurrence of the Commissioner of Police, hereby make the following bye-laws :—

1. These bye-laws may be cited as the Nicosia Municipal (Traffic) (Amendment) Bye-laws, 1956, and shall be read as one with the Nicosia Municipal (Traffic) Bye-laws, 1952 to 1955 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Nicosia Municipal (Traffic) Bye-laws, 1952 to 1956.

2. The proviso to bye-law 13 (o) of the principal Bye-laws is hereby deleted and the following proviso substituted therefor :—

"Provided that in the case of a motor vehicle such speed shall not exceed thirty miles per hour or such lesser speed as may be indicated by a street sign in respect of the street to which such sign relates, and any speed in excess of such speed shall be deemed to be a speed likely to endanger human life or to cause harm or injury to any person or property within the meaning of Bye-law 13 (o)".

The above Bye-laws have been approved by His Excellency the Governor.
