

**No. 697.****THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS,  
1949 AND 1954.**

In pursuance of the provisions of section 12 (4) of the Irrigation (Private Water) Association Laws, 1949 and 1954, the following rules made by the Committee of the Irrigation Association of Kato Zodia ("Komitis Water"), in the District of Nicosia, are published in the *Gazette*.

1. These rules may be cited as the Irrigation (Private Water) Association of Kato Zodia "Komitis Water" (Amendment) Rules, 1956, and shall be read as one with the Irrigation (Private Water) Association of Kato Zodia ("Komitis Water") Rules, 1950 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Irrigation (Private Water) Association of Kato Zodia ("Komitis Water") Rules, 1950 and 1956.

2. Rule 6 (2) of the principal Rules is hereby amended by the deletion therefrom of the words "31st August" and the substitution therefor of the words "1st January".

3. Rule 6 (3) of the principal Rules is hereby repealed and the following rule substituted therefor :—

"Rule 6.—(3) The treasurer shall receive a remuneration of 3 per centum of all rates and charges collected by him as in paragraph (1) hereof, and, in addition he shall be paid such of his out of pocket expenses as may be sanctioned by the Committee."

4. Rule 7 of the principal Rules is hereby amended by the deletion therefrom of the words "forty shillings" and the substitution therefor of the words "six pounds".

5. Rule 8 of the principal Rules is hereby amended by the deletion therefrom of the words "31st August" and the substitution therefor of the words "31st December".

6. Rule 9 of the principal Rules is hereby amended by the deletion therefrom of the words "1st day of September" and the substitution therefor of the words "1st day of January".

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "sixty shillings" and the substitution therefor of the words "six pounds".
