

No. 723.**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia and Kyrenia, do hereby give notice that in the interests of public order and safety, and for the maintenance of supplies and services essential to the life of the community, have taken possession of the land specified in the Schedule hereto until further notice.

2. The use of the said land for the erection of temporary garages for security vehicles and general purposes by members of the Police Force and H.M. Forces engaged on inland security is hereby authorized.

3. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such act as may be necessary for the purpose of their occupation.

4. The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this Order shall remain in force.

SCHEDULE.

The privately-owned land, with everything standing thereon, situated at Lefka village, under Plot No. 10 of Block E, Lefka, more particularly defined as the area coloured red on the plan signed by the Commissioner of Nicosia and Kyrenia and dated the 19th day of July, 1956, a copy of which has been deposited in the Commissioner's Office, at Lefka.

No. 724.**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 8) 1956.****ORDER MADE UNDER REGULATION 40.**

In exercise of the powers vested in me by Regulation 40 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia and Kyrenia, do hereby order that all establishments owned and managed, or managed by Greek Cypriots, and situated within the municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa, shall be closed, and shall remain closed as from 04.00 hours on 26th July, 1956, until further notice:

Provided that hotels may remain open for the purposes of catering for residents therein.
