**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 10) 1956.**

ORDER MADE UNDER REGULATION 38 (1).

In exercise of the powers vested in me by Regulation 38 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 10) 1956, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia and Kyrenia, do hereby order as follows :—

1. This Order may be cited as the Protected Areas (Nicosia District) Order, 1956.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purposes of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 10) 1956.

SCHEDULE.

Place	Limits
Police H.Q. and Fire Station, Paphos Gate, Nicosia.	All that area known as Police Headquarters and the Fire Station, Paphos Gate, Nicosia, being the buildings, parade ground and other land situated on the walls in the area bounded on the north side by Paphos Gate Entrance on the east side by Regaena Street, excluding the public car park at Tripoli Bastion, and on the south and west sides by the outer perimeter of the Tripoli Bastion and the Paphos Gate Entrance more particularly defined as the area bordered red on the Government Survey plan of Nicosia Sheet XXI.46.W and XXI.46.E signed by the Commissioner on 31st July, 1956, and deposited in his Office in Nicosia.

THE CURFEWS LAWS, 1955.

LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Paphos District No. 25) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 28th day of July, 1956.

Within the village boundaries of Nata.

SECOND SCHEDULE.

From 05.00 hrs. to 17.00 hrs. on the 28th July, 1956.
