THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 10) 1956.

ORDER MADE UNDER REGULATION 38A.

In exercise of the powers vested in him by regulation 38A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 10) 1956, His Excellency the Governor considering it necessary in the public interest so to do, hereby orders that the areas set out in the first column of the Schedule hereto, excluding the areas set out in the second column, be declared danger areas subject to the following condition :—

The limits and extent of the area shall be demarcated by notices in English, Greek and Turkish put up at the point where each road or recognized track enters the area and on any prominent and accessible feature lying in the boundaries of the said area.

2. This Order may be cited as the Danger Areas (Troodos Sub-Area No. 1) Order, 1956, and shall come into effect on 16th August, 1956.

<i>Area "A" :</i>	
<p>All that area, including part of the Paphos Main State Forest, within the villages of Kambos, Milikouri, Chakistra, Lefka (part), Yerakies (part), Lemithou (part), Phini (part), Kato Platres (part), Omodhos (part), Ayios Nikolaos (part) and Ayios Ioannis (part), the boundary of which commences at the junction of the Kambos-Vroisha village boundary with the Nicosia-Paphos District boundary, locality "Kefalos tis Mele-nadis" and proceeds north-eastwards along the said village boundary to its junction with the Kambos Xero-vounos village boundary, locality "Vrysi tou Khristo-forou" ; thence north-eastwards along the last men-tioned boundary to its junction with the Kambos-Varisha village boundary, locality "Ippos" ; thence southwards and north-eastwards along the last men-tioned boundary to its junction with the Kambos-Ambe-likou village boundary, locality "Muti tou Khontrou" ; thence in a south-easterly direction along the last men-tioned village boundary to its junction with the Kambos-Lefka village boundary, locality "Alonakia" ; thence southwards along the last mentioned boundary to its junction with the Lefka-Yerakies village boundary, locality "Shakhourin" ; thence south-eastwards along the last mentioned boundary to its junction with the Lefka-Kalopanayiotis village boundary, locality "Skotini" ; thence north-eastwards along the last mentioned boundary to the Lefka-Prodhromos main road, locality "Kokkinokremmos" ; thence southwards along the said road to forest cairn No. 1056 on the bound-ary of the said forest ; thence in a southerly and easter-ly direction along the said forest boundary to its junction with the left bank of the River Xeros, locality "Kako-rotsia" ; thence north-eastwards along the said bank of the said river to its junction with the said district boundary ; thence in a northerly direction along the last mentioned boundary to the point of commencement.</p>	<p>(i) <i>Villages</i> : The built-up areas of the villages of Kambos, Chakistra and Milikouri.</p> <p>(ii) <i>Monasteries</i> : Kykko Mo-nastery.</p>
