CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.****(SECTION 12 (2).)**

No. 80.**THE TOBACCO LAWS, 1932 TO 1954.****NOTICE UNDER SECTION 9.**

Notice is hereby given that in exercise of the powers vested in me by section 9 of the Tobacco Laws, 1932 to 1954, any leaf tobacco, other than fumigated tobacco, in the possession of any grower shall, when dry, be graded and baled at any time before the 15th day of March, 1956.
