

**No. 808.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 10) 1956.****ORDER MADE UNDER REGULATION 44.**

In exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 10) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I give notice that in the interests of public order and safety I have taken possession until further notice of the land specified in the Schedule hereto.

2. Her Majesty's Forces are hereby authorized to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest as may be necessary for security purposes.

3. The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

**SCHEDULE.**

1. All vegetation within ten feet of the Famagusta-Dherinia road in plots 9, 11, 12, 48, 49, 59, 60, 66, Block H, Ayia Zoni Quarter, together with all vegetation preventing access from plot 9 to plot 12 within 10 yards of the road.

2. All vegetation standing between the Orange trees in plots 24 and 46 Block H, Ayia Zoni Quarter and plot 41.

3. All vegetation within ten feet of the Famagusta-Dherinia road in plots 78, 79, 77, 2, 57, 76, 13, 65, 21, 23, 24, 38, 40 and 41, Block A, Ayios Memnon Quarter, together with all vegetation preventing access from plot 21 to plot 23 within 10 yards of the road.

4. All vegetation in plot 87 Block E, Kato Varosha Quarter, within ten feet of the track separating it from plot 66, Block A, Ayios Memnon.

**No. 809.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 10) 1956.****ORDER MADE UNDER REGULATION 40.**

In exercise of the powers vested in me by Regulation 40 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 10) 1956, I, the Commissioner of Limassol, do hereby order that all establishments, as defined in the Schedule hereto, owned or managed or controlled by Greek Aliens or Greek Cypriots, within the Municipal limits of Limassol and within a radius of 5 miles from the Commissioner's Office, Limassol, shall be closed and shall remain closed between 17.00 and 23.30 hours daily from 9th to 11th August, inclusive.

This Order shall come into effect as from the 9th August, 1956.

**SCHEDULE.**

Cinematograph theatres, theatres, cabarets, clubs, bars, restaurants, coffee-shops, bars in hotels, restaurants in hotels and any other place or premises of public resort or entertainment whatsoever.
