BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF
KYTHREA.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Kythrea hereby make the following bye-laws :—

1. These Bye-laws may be cited as the Municipal Corporation (Kythrea) (Amendment) Bye-laws, 1956, and shall be read as one with the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1954 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these Bye-laws may together be cited as the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1956.

2. Bye-law 16 of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1946) is hereby amended by the deletion therefrom of the words "one piastre" (line 3) and the substitution therefor of the words "ten mils".

3. Bye-law 21G of the principal Bye-laws (as set out in the Kythrea (Amendment) Bye-laws, 1939) is hereby repealed and the following bye-law substituted therefor :—

"21G. The following fees shall be paid to the inspector by the person in charge of any animal brought to the animal market :—

	<i>mils</i>
(a) For every camel, mule, horse or ox	50
(b) For every ass	20

Provided that the young ones of the above named up to 12 months old if running loose with their mothers shall be admitted free of charge into the animal market.

(c) For every goat or sheep	15
(d) For every kid or lamb under three months	10
(e) For every pig—under three months	15
over three months	50."

4. Bye-law 21N of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1946) is hereby amended by the deletion therefrom of the words "one piastre" and the substitution therefor of the words "ten mils".

5. Bye-law 61A of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1954) is hereby repealed and the following bye-law substituted therefor :—

"61A.—(1) A fee of not less than the minimum and not exceeding the maximum fixed under this bye-law shall be paid to the town clerk and

treasurer by all persons who keep or own any of the buildings or places mentioned herein below :—

(2) The fee shall be paid in respect of the period ending on the 31st December of each year, irrespective of the time when it becomes chargeable."

6. Bye-law 68 (1) and 68 (2) of the principal Bye-laws (as set out in the Kythrea Municipal Bye-laws, 1932) is hereby repealed and the following bye-law substituted therefor :—

"68—(1) The following charge shall be paid by every person posting or exhibiting any notice or advertisement on any hoarding, that is to say :—

*Size of Notice or Advertisement,
not exceeding—*

	2×2 feet	3×3 feet
For each week or part thereof	50 mils	100 mils

(2) The charge in this bye-law prescribed shall be paid to the town clerk and treasurer."

7. Bye-law 69 of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1939) is hereby amended by the deletion therefrom of the words "one shilling" (line 1) and the substitution therefor of the words "fifty mils".

8. Paragraph 1 (b) of bye-law 72B of the principal Bye-laws (as set out in the Kythrea (Amendment) Bye-laws, 1950) is hereby repealed and the following paragraph substituted therefor :—

"(b) The entertainment duty shall be payable by the manager and shall be as follows :—

	<i>mils</i>
(i) For entrance fee not exceeding 30 mils ..	5
(ii) For entrance fee exceeding 30 mils but not exceeding 50 mils	10
(iii) For entrance fee exceeding 50 mils: for every 50 mils or part thereof	10."

9. Bye-law 72M (1) of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1948) is hereby amended :—

(a) by the deletion therefrom of the words “two paras” (line 5) and the substitution therefor of the words “three mils for every ten okes or part thereof.”

(b) by the repeal of the provisos (a), (b) and (c) and the substitution therefor of the following provisos :—

“(i) the fee to be collected in each case shall be a multiple of five mils.

(ii) when such fee is not an exact multiple of five mils the nearest multiple of five mils whether higher or lower shall be collected.

(iii) the minimum fee for any weighing, measuring or testing shall be five mils.”

10. The first schedule of the principal Bye-laws (as set out in the Kythrea Municipal (Amendment) Bye-laws, 1948) is hereby repealed and the following Schedule substituted therefor :—

Fees shall be calculated on the actual weight of the goods weighed at the above rates :

Provided that—

- (a) the fee collected in each case shall be a multiple of five mils ;
- (b) when such fee is not an exact multiple of five mils the nearest multiple of five mils whether higher or lower shall be collected ;
- (c) the minimum fee for any one weighing or measuring shall be 5 mils."

The above Bye-laws have been approved by His Excellency the Governor.
