THE CUSTOMS MANAGEMENT LAWS, 1954 AND 1955.

ORDER IN COUNCIL No. 2861

MADE UNDER SECTION 133.

In exercise of the powers vested in him by section 133 of the Customs Management Laws, 1954 and 1955, His Excellency the Governor, with the advice of the Executive Council, hereby orders as follows:-

1. This Order may be cited as the Exemption from Customs Duty (Council

of Voluntary Welfare Workers) Order, 1956.

2. In this Order:

"Council of Voluntary Welfare Workers" includes the Young Women's Christian Association, at Nicosia and at Berengaria; the Church of England Institute at Dhekelia; the Young Men's Christian Association at Episkopi; Hibbert House at Nicosia; the Church of Scotland Bookshop at Kyrenia, and such other member organizations as may from time to time be certified by the Comptroller of Customs and Excise to be a "member organization of the Council of Voluntary Welfare Workers".

3. The articles set out in the Schedule hereto shall, when imported into the Colony by or on behalf of the Council of Voluntary Welfare

Workers, be admitted free of Customs Duty.

THE PUBLIC HEALTH (VILLAGES) LAW. CAP. 142.

ORDER IN COUNCIL No. 2862

MADE UNDER SECTION 10.

Authority to the Village Health Commission of Dhali (Nicosia District) to contract a loan.

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

- 1. The Village Health Commission of Dhali (Nicosia District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of two thousand pounds (£2,000) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—
 - (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in ten equal annual instalments (comprising sinking fund and interest);
