THE WELLS LAW.

CAP. 312 AND LAWS 19 OF 1951 AND 42 OF 1953.

NOTICE UNDER SECTION 3A (2).

Whereas His Excellency the Governor, being satisfied that special measures for the conservation of water in the area set out in the Schedule hereto are necessary in the public interest, proposes to make an Order in respect of such areas under section 3A of the Wells Law :

Now, therefore, by the direction of His Excellency the Governor notice is hereby given that the particulars of the proposed Order shall be as set out in the Schedule hereto and that a copy of the draft of the proposed Order and every relevant map and plan may be inspected at the office of the Commissioner of the District in which the area affected is situated during office hours and free of charge during a period of fourteen days of the publication of this notice in the *Gazette* and that any person may, within the same period, by notice addressed to the Commissioner of the District in which the area affected is situated, object to the making of the Order.

SCHEDULE.

Defined Area.

In the villages of Morphou, Syrianokhori, Nikitas, Prastio, Ghaziveran, Elea, Petra and Pendayia, in the District of Nicosia, the area within the following boundary, that is to say :—

The boundary commences at the point on the mouth of the "River Aloupos" which is on the left bank of the said river and proceeds eastwards along the said bank of the said river to a point where it is cut by the straight line from forest cairn No. 195 of the Ayia Irini Main State Forest to the most northern point of plot No. 109 of Block K of Ayios Yeoryios Quarter, Morphou village ; thence south-westwards in a straight line to the most northern point of plot No. 58 of Block M of the said quarter ; thence south-westwards in a straight line to the north-western corner of plot No. 2 of Block D of Ayios Yeoryios Quarter, Prastio village; thence south-westwards in a straight line to the south-western corner of plot No. 32 of Block F of the said Quarter; thence south-westwards in a straight line to the most northern point of plot No. 159 of Block C of the said Quarter; thence south-westwards in a straight line to the most northern point of plot No. 277 of the Government Survey Plan No. XIX.61, locality "Karteri"; thence south-westwards in a straight line to the most northern point of plot No. 193 of the said plan, locality "Asprokhoman"; thence south-westwards in a straight line to the southwestern corner of plot No. 5 of the Government Survey Plan No. XXVIII.5, locality "Xynevrismenous"; thence south-westwards in a straight line to the north-western corner of plot No. 89 of the Government Survey Plan No. XXVIII.4, locality "Marathies", which corner is on the right bank of the River Karyotis; thence northwards along the said bank of the said river to the sea-shore ; thence in a northerly direction along the sea-shore to the point of commencement, all which boundary is more particularly delineated on a plan marked Serial No. 1663 signed by the Commissioner of Nicosia and Kyrenia bearing date 25th July, 1956, and deposited at the office of the Commissioner of Nicosia and Kyrenia.
