## THE CHILDREN LAW, 1956.

### REGULATIONS MADE UNDER SECTION 26.

In exercise of the powers vested in him by Regulation 26 of the Children Law, 1956, His Excellency the Governor hereby makes the following regulations:—

1. These Regulations may be cited as the Voluntary Homes (Registration) Regulations, 1956, and shall come into operation on the 23rd day of August,

1956.

2. Application for registration of a voluntary home under section 24

of the Children Law, 1956, shall-

(a) if the home was open for the reception of children on the 23rd day of August, 1956, be made in the form set out in Part I of the Schedule to these Regulations;

(b) in the case of a home intended to be opened after the 23rd day of August for the reception of children, be made in the form set out

in Part II of the Schedule to these Regulations.

3. Notice of refusal of registration shall be as set out in Part III of the Schedule to these Regulations.
