THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 11) 1956.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations 1955 to (No. 11) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia and Kyrenia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the community, have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said land as an annex to the General Post Office is hereby authorized.

3. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this Order shall remain in force.

SCHEDULE.

The ground floor entrance, hall, garden with outbuildings and all the first floor buildings of the property under Plot Nos. 33/4 and 33/6/1 of Block 4 Arab Ahmed Pasha Quarter, Nicosia, and situated at No. 20, Saray Onu Street, Nicosia, more particularly defined on the plan signed by the Commissioner, Nicosia, dated 1st September, 1956, and deposited in his office in Nicosia.

ORDER MADE UNDER REGULATION 39.
