## THE EMERGENCY POWERS (PUBLIC/SAFETY AND CORDER) REGULATIONS, 1955 TO (No. 11) 1956.

## ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in the Governor under Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the Gazette of 22nd December, 1955, I, Reginald Norman Kershaw Beresford, Commissioner of Nicosia and Kyrenia, hereby order that the following streets in Nicosia or such parts thereof as are set out in the Schedule hereto shall be "One Way Streets" as indicated by traffic signs.

- 13. Eleftheria Street with "No Entry" from the corner of Artemis Street.
- 14. Vitsi Street with "No Entry" from Paphos Street. 15. Tudchar Bashi Street with "No Entry" from Ledra Street.
- 16. Themistocleous Street with "No Entry" from Trikoupis Street.
