THE DANGEROUS DRUGS LAW.

CAP. 73 AND LAW 39 OF 1953.

ORDER IN COUNCIL No. 2875

MADE UNDER SECTION 12 (2).

Cap. 73. 39 of 1953.

Whereas by sub-section (2) of section 12 of the Dangerous Drugs Law, power is conferred upon the Governor by Order in Council to declare that Part III of the Law shall apply to any drug of whatever kind in the same manner as it applies to the drugs mentioned in sub-section (1) of the said section 12 if it appears to the Governor that the drug is, or is likely to be, productive, if improperly used, of ill effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine or is capable of being converted into a substance which is, or is likely to be, productive, if improperly used, of such effects:

And whereas it appears to the Governor that the drugs specified in the Schedule to this Order are, or are likely to be, productive, if improperly used, of effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine:

Now, therefore, in exercise of the powers conferred upon him by subsection (2) of section 12 of the Dangerous Drugs Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and declare as follows:

- 1. This Order may be cited as the Dangerous Drugs (Application of Law) Order, 1956.
- 2. Part III of the Dangerous Drugs Law (which provides that it shall not be lawful to import or export any drug to which that Part applies except under licence, and empowers the Governor-in-Council to make regulations for the purpose of preventing the improper use of such drugs), shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part III applies to the drugs mentioned in sub-section (1) of section 12 of the said Law.

SCHEDULE.

- 1. 1:3 Dimethyl-4-phenyl-4-propionyloxyhexamethyleneimine, its salts and any preparation, admixture, extract or other substance containing any proportion of 1:3-dimethyl-4-phenyl-4-propionyloxyhexamethyleneimine.
- 2. 3-Hydroxy-N-phenethylmorphinan, its salts and any preparation, admixture, extract or other substance containing any proportion of 3-hydroxy-N-phenethylmorphinan.
- 3. 4-Morpholino-2:2-diphenyl ethyl butyrate, its salts and any preparation, admixture, extract or other substance containing any proportion of 4-morpholino-2:2-diphenyl ethyl butyrate.
- 4. 4-Dimethylamino-1:2-diphenyl-3-methyl-2-propionyloxybutane, its salts and any preparation, admixture, extract, or other substance containing any proportion of 4-dimethylamino-1:2-diphenyl-3-methyl-2-propionyloxybutane.
