## ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, and delegated to me by Notification No. 736 published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Warren Frederick Martin Clemens, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the Community, have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said land as accommodation for members of the Inland Security Forces is hereby authorized.

3. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this Order shall remain in force.

#### SCHEDULE.

All that privately-owned property situated in Nicosia Town comprising the entrance on the Ground Floor and the 1st and 2nd floors of the building known as the "International Hotel" and all appurtenances thereto, being plots Nos. 125, 129/1 and on 125/1, 126, 120, 121, 120/1, 121/1, 122, 123, 124, 128, 129, 130, 130/1 of Block 9 Nicosia, Korkoud Eff. and Iblik Bazar quarter, more particularly defined as the area coloured red on the plan signed by the Commissioner, Nicosia and Kyrenia, and dated the 15th September, 1956.

# ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in the Governor Inder Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of 27th December, 1955, I, Warren Frederick Martin Clemens, the Commissioner of Nicosia, do hereby prohibit until further notice :--

(i) The use of all motor vehicles, motor cycles and pedal cycles within

the Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa as from 18.30 hours on Wednesday, 19th September, 1956, until further notice:

- Provided that this part of this Order shall not apply to :--
  - (a) persons of non-Cypriot origin subject to the production on demand of a passport proving that they are of non-Cypriot origin;
  - (b) public omnibuses, lorries and vans engaged on legitimate commerce or trade;

between the hours of 04.00 and 18.30 daily; and to:-

(a) members of Her Majesty's Forces in uniform;

- (b) members of the Cyprus Police Force when on duty;
- (c) the holders of official Curfew Passes issued by the Commissioner of Nicosia or by the Assistant Commissioner of
- Police of the Nicosia Division, when travelling on duty. (ii) The parking or leaving of pedal cycles or motor cycles in or on the public roads within the areas defined above during the continuance of this Order.

The Prohibition of Parking of Vehicles (Nicosia No. 1) Order, 1956 (published in Supplement No. 3 to the Gazette of 30th May, 1956) shall, in so far as it is consistent with the provisions of this Order, be in full force and operation.

## THE CURFEWS LAWS, 1955. LAWS 17 AND 47 OF 1955.

### ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the Gazette of the 19th July, 1956, I do hereby order as follows :----

1. This Order may be cited as the Curfews (Nicosia District No. 28)

Order, 1956. 2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 19th day of September, 1956.

From 04.45 until further notice.
