THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 11) 1956.

ORDER MADE UNDER REGULATION 38 (1).

In exercise of the powers vested in me by Regulation 38 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby order as follows:—

- 1. This Order may be cited as the Protected Areas (Nicosia District) Order (No. 2) 1956.
- 2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purposes of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956.

SCHEDULE.

Place | Limits

The Secretariat Compound and Government Residential Quarters to the north thereof. All that area of land known as the Secretariat Compound, Nicosia Town, and the Government Residential Quarters, to the north, comprising lands, buildings and all appurtenances thereto and including plot No. 9 of Block A, Ayii Omoloyitadhes Quarter, plots Nos. 11, 12, 13, 14, 15, 16, 17, 18, 19, 20 and 21 of Block 25, Trypiotis Quarter, more particularly defined as the area delineated in red on the plan signed by the Commissioner, Nicosia and Kyrenia, dated the 25th September, 1956, and deposited in his Office at Nicosia.

THE LAND ACQUISITION LAW. CAP. 233 AND LAWS 26 OF 1952 AND 43 OF 1955.

Notice under Section 6.

With reference to the Notification published under No. 68 in Supplement No. 3 to the *Gazette* of the 13th February, 1952, as amended by Notification No. 362 in Supplement No. 3 to the *Gazette* of the 3rd May, 1956, notice is hereby given that the following lands and easements are required by the Governor for the undertaking of public utility mentioned therein:—
