## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Nicosia and Kyrenia District No. 1/1956) Order, 1956.

2. No person within the village boundaries of Kythrea shall be out of doors on the dates and during the hours prescribed in the Schedule hereto except under the written authority of the Commissioner of Nicosia, or the Superintendent of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 2nd day of February, 1956.

Between the hours of 0600 a.m. on February the 2nd, 1956, and 0600 a.m. on February the 3rd, 1956.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1956.

## ORDER MADE UNDER REGULATION 38 (1).

I, the Commissioner of Limassol, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1956, do hereby order as follows:—

1. This Order may be cited as the Protected Areas (Limassol District No. 1) Order, 1956.

2. The areas specified in the Schedule hereto are hereby declared to be protected areas for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1956.

## SCHEDULE.

(a) The area inside the perimeter fence erected by 45 Royal Marine Commando at Platres, more specifically shown as the area bounded in red on the map signed by me and dated the 25th day of January, 1956, one copy of which is deposited in the Commissioner's Office, Limassol, and another in the Office of the Inspector of the Platres Improvement Board, in Platres.

(b) That portion of the privately-owned premises comprising an explosives store and the land situate within 40 feet of the existing fence surrounding the explosives store and including the approach road thereto, situate upon plot 81/1 of Plan 16, Sheet LVIII, Zakaki village, more particularly defined as the area bounded in blue on the plan signed by the Commissioner, Limassol, and dated the 26th day of January, 1956.
