THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 11) 1956.

ORDER MADE UNDER REGULATION 40.

In exercise of the powers vested in me by Regulation 40 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby order that all establishments owned and managed, or managed by Greek Cypriots, and situated within the Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa, shall be closed, and shall remain closed as from 19.00 hours on 28th September, 1956, until further notice :

Provided that hotels may remain open for the purposes of catering for residents therein.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 11) 1956.

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in the Governor by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, and delegated to me by Notification No. 807, published in Supplement No. 3 to the *Gazette* of 27th December, 1955, I, Warren Frederick Martin Clemens, the Commissioner of Nicosia and Kyrenia, do hereby order as follows :—

1. This Order may be cited as the Vehicular Traffic (Nicosia District) (Restriction) Order, 1956.

2. In this Order :—

“ Vehicle ” means pedal cycles and motor cycles.

3. The use of all vehicles within the Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa, is hereby prohibited from 04.00 hours on Sunday, 30th September, 1956, until further notice :

Provided that this Order shall not apply to :—

(a) Members of the Police Force and Her Majesty's Forces ;

(b) Persons who can, by the production of an identity card issued under the Emergency Powers (Registration Areas) (No. 2) Regulations, 1956, prove that they are not Greek Cypriot males born in or after the year 1930.

ORDER MADE UNDER REGULATION 44.

In exercise of the powers vested in His Excellency the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, and delegated to me by Notification No. 736

published in Supplement No. 3 to the *Gazette* of 26th November, 1955, I, Warren Frederick Martin Clemens, Commissioner of Nicosia, do hereby give notice that in the interests of public order and safety and for maintaining supplies and services essential to the life of the Community, have taken possession with immediate effect of the land specified in the Schedule hereto until further notice.

2. The use of the said land as accommodation for members of the Security Forces is hereby authorized.

3. The authority using the land in pursuance of this Order is entitled to do thereon or in relation thereto such acts as may be necessary for the purposes of their occupation.

4. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited during the period this Order shall remain in force.

SCHEDULE.

The privately owned lands with all appurtenances thereto situate at Kythrea village and owned under Plots Nos. 272 and 273 of Block B, Ayia Marina Quarter, Kythrea, more particularly defined as the area coloured red on the plan signed by the Commissioner, Nicosia and Kyrenia, dated the 25th day of September, 1956, and deposited in his Office in Nicosia.

THE CURFEWS LAWS, 1955.

LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Nicosia District No. 29) Order, 1956.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 28th day of September, 1956.

FIRST SCHEDULE.

Greek quarters within the walls of Nicosia.

SECOND SCHEDULE.

From 17.00 hrs. on 28.9.1956, until further notice.
