THE WELLS LAW.

CAP. 312 AND LAWS 19 OF 1951 AND 42 OF 1953.

NOTICE UNDER SECTION 3A (2).

Whereas His Excellency the Governor, being satisfied that special measures for the conservation of water in the area set out in the Schedule hereto are necessary in the public interest, proposes to make an Order in respect of such areas under section 3A of the Wells Law :

Now, therefore, by the direction of His Excellency the Governor notice is hereby given that the particulars of the proposed Order shall be as set out in the Schedule hereto and that a copy of the draft of the proposed Order and every relevant map and plan may be inspected at the office of the Commissioner of the District in which the area affected is situated during office hours and free of charge during a period of fourteen days of the publication of this notice in the *Gazette* and that any person may, within the same period, by notice addressed to the Commissioner of the District in which the area affected is situated), object to the making of the Order.

SCHEDULE.

Defined Area.

In the villages of Dhali and Potamia, in the District of Nicosia, the area within the following boundary, that is to say :—

The boundary commences at the north-eastern corner of plot No. 13 of Block C, Dhali village, and proceeds north-eastwards in a straight line (through the Yialias river bed) to the south-eastern corner of plot No. 467 of Block C, Dhali village ; thence eastwards along the southern boundary of plot No. 170 of the Government Survey Plan No. XXI.49 to the south-eastern corner of the said plot ; thence north-eastwards (across the Yialias river) in a straight line to the most northern point of plot No. 189 of the said plan ; thence southwards in a straight line to the most southern point of plot No. 202 of the said plan ; thence southwards in a straight line to the most southern point of plot No. 590 of Block D, Dhali village ; thence north-westwards along the boundaries of and including the said plot (part), plots Nos. 100, 558 and 108 of Block D, Dhali village, to the south-western corner of the last mentioned plot ; thence in a westerly direction along the boundaries of and including plots Nos. 183, 187, 258, 259, 261, 268, 269, 270, 271, 251, 249, 247, 582, 581 and 231 of Block C, Dhali village, to the north-western corner of the last mentioned plot ; thence northwards in a straight line to the most northern point of plot No. 224 of Block C, Dhali village, which point is on the right bank of the Yialias river ; thence north-westwards in a straight line (across the said

river) to the most southern point of plot No. 212 of Block C, Dhali village ; thence northwards along the western boundary of the said plot to the north-eastern corner of plot No. 219 of Block C, Dhali village ; thence northwards in a straight line to the most southern point of plot No. 543 of Block C, Dhali village ; thence northwards along the boundaries of and including the said plot, plots Nos. 542, 544, 545, 587 and 586 of Block C, Dhali village, to the south-western corner of the last mentioned plot, which corner is on a track leading from the village of Dhali to the village of Ayios Sozomenos ; thence north-eastwards along the said track to the most northern point of plot No. 12 of Block C, Dhali village ; thence in a north-easterly direction along the boundaries of and including the said plot and plot No. 13 of Block C, Dhali village, to the point of commencement, all which boundary is more particularly delineated on a plan marked serial No. 1668 signed by the Commissioner of Nicosia and Kyrenia bearing date 12th September, 1956, and deposited at the Office of the Commissioner of Nicosia and Kyrenia.

THE PENSIONS LAW.

CAP. 288 AND LAWS 4 OF 1952 AND 1 OF 1955.

REGULATIONS MADE UNDER SECTION 3.

Cap. 288,
4 of 1952
1 of 1955.

In exercise of the powers vested in him by section 3 of the Pensions Law, His Excellency the Governor, with the advice of the Executive Council and with the sanction of the Secretary of State, has been pleased to make the following regulations :—

Cap. 288,
Schedule.

1. These Regulations may be cited as the Pensions (Amendment) Regulations, 1956, and shall be read as one with the Pensions Regulations (hereinafter referred to as “ the principal Regulations ”) as from time to time amended.

2. Regulations 19 and 19A of the principal Regulations are hereby revoked and the following regulation substituted therefor :—

“ Emolu-
ments to be

pension or
gratuity.

19.—(1) For the purpose of computing the amount of the pension or gratuity of an officer who has had a period of not less than three years' pensionable service before his retirement—

(a) in the case of an officer who has held the same office for a period of three years immediately preceding the date of his retirement, the full annual pensionable emoluments enjoyed by him at that date in respect of that office shall be taken ;

(b) in the case of an officer who at any time during such period of three years has been transferred from one office to another, but whose pensionable emoluments have not been changed by reason of such transfer or transfers, otherwise than by the grant of any scale increment, the full annual pensionable emoluments enjoyed by him at the date of his retirement in respect of the office then held by him shall be taken ;
