**ORDER MADE UNDER REGULATION 34 (1) (b).**

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1956 and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby prohibit the circulation of any vehicular traffic (including motor cycles and bicycles) along the roads specified in the Schedule hereto in Platres from half an hour after sunset until half an hour before sunrise until further notice.

**NOTICE UNDER SECTION 6.**
