take possession of the land and, in connection with the taking possession and making use of the land, has been pleased to direct and order as follows :-

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorized to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

ORDER MADE UNDER REGULATION 35A.

Whereas it has come to my notice that illegal slogans have been painted on various public roads within and adjacent to the area of the Improvement Board of Trikomo, now therefore, I, the Commissioner of Famagusta, in exercise of the powers conferred upon me by Regulation 35A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1957, do hereby order as follows :—

1. This Order may be cited as the Removal of Illegal Slogans from Roads (Famagusta District No. 6) Order, 1957. 2. The use of the roads listed in the Schedule hereto is prohibited. 3. This Order shall come into force at 1800 hours on Monday, 28th October, 1957, and shall remain in force until further notice.
