ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 18th July, 1956, and published in Supplement No. 3 to the *Gazette* of the 26th July, 1956, under Notification No. 700 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Yerolakkos (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 1285 and 704 published in Supplement No. 3 to the *Gazettes* of the 28th December, 1956 and 18th July, 1957, respectively, the Order was extended for further periods of six months up to the 17th January, 1958 ;

Whereas by Order dated the 7th January, 1956, and published in Supplement No. 3 to the *Gazette* of the 10th January, 1956, under Notification No. 15 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Ayios Memnon and Stavros Quarters, Famagusta (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;
