ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 6th January, 1956, and published in Supplement No. 3 to the *Gazette* of the 10th January, 1956, under Notification No. 14 (as amended by Notification No. 333 published in Supplement No. 3 to the *Gazette* of the 26th April, 1956) (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Chiflikoudhia Quarter, Limassol (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 642, 1284 and 710 published in Supplement No. 3 to the *Gazettes* of the 12th July, 1956, 28th December, 1956 and 18th July, 1957, respectively, the Order was extended for further periods of six months up to the 5th January, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
