## No. 126. THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 7, 25 AND 33.

This Order may be cited as the Exchange Control (Payments) Amendment Order, 1957, and shall be read as one with the Exchange Control (Payments) Orders, 1954 to 1956 (hereinafter referred to as "the principal Order ") and the principal Order and this Order may together be cited as the Exchange Control (Payments) Orders, 1954 to 1957.

2. The principal Order is hereby amended by inserting before item 1 thereof in the first column the word and figures "or Austria" and in the

second column-

"(a) Payment in sterling from a Transferable Account of a person resident in a Transferable Account territory.

(b) Payment in sterling from an account of a person resident in any territory specified in the First Schedule to this Order.

(c) Payment in Austrian schillings.".

3. This Order shall be deemed to have been made and to have come into force on the second day of January, 1957.
