THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 17) 1956.

ORDER MADE UNDER REGULATION 34 (1) (b).

In exercise of the powers vested in the Governor under paragraph 34 (1) (b) of the above Regulations and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby order as follows:—

Until further notice no civilian vehicle passing through Episkopi Cantonment between milestones 66 and 71 on the Limassol-Paphos Road shall stop at any point along the said road other than at the points set aside and marked as stopping places.
