THE EMERGENCY POWERS (CONTROL OF BUILDING OPERATIONS) (No. 2) REGULATIONS, 1956.

NOTIFICATION UNDER REGULATION 7.

In exercise of the powers vested in him by Regulation 7 of the Emergency Powers (Control of Building Operations) (No. 2) Regulations, 1956, His Excellency the Governor has been pleased to exempt the following building from the provisions of the said Regulations :—

Two rooms and a corridor to be built on to the auxiliary building in the yard of the premises owned by Evcaf and occupied by the Turkish Consulate, situate on plot No. 38 of block No. 26, Ayios Andreas quarter, Nicosia, on the Government Survey Plan No. XXI.46.5.III.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 1) 1957.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorise its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 1) 1957, which I have been authorised to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Nicosia and Kyrenia, hereby take possession of the land and, in connection with the taking, possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

SCHEDULE.

All that privately owned land situated at Eylenja Village that is to say :—

The land shown under Part Plots Nos. 897 & 898 of the Government Survey Sheet Plan XXI.63.W.2 Block B Eylenja Village, all of which said land is more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, dated 25th January, 1957, a copy of which is deposited in the office of the Commissioner, Nicosia and Kyrenia, at Nicosia.

THE CURFEWS LAWS 1955.

LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 11) Order, 1957.

2. No person within the area prescribed in the Schedule hereto shall be out of doors as from 08.30 hours on 11th February, 1957, until further notice, except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any person who is (a) not a Greek Cypriot born on or after 1st January, 1936, (b) a Government servant, (c) a member of the Cyprus Police Force on duty, or (d) a pupil attending elementary school.

This Order is in addition to and not in derogation of the Order dated 5th day of November, 1956, published as Notification No. 1061 in Supplement No. 3 to the *Gazette* of 8th November, 1956, as amended by Notification No. 19 dated 24th December, 1956 and published in Supplement No. 3 to the *Gazette* of 3rd January, 1957, and Order dated 6th February, 1957.

SCHEDULE.

The Municipal limits of Nicosia and the village areas of Strovolos, Engomi, Ayios Dhometios, Trakhonas, Omorphita, Beuyuk Kaimakli and Palouriotissa.
